

## GEN 3.3 AIR TRAFFIC SERVICES

### GEN 3.3.1 Responsible service

The Air Navigation Services Department of Namibia Civil Aviation Authority is the responsible authority for the provision of air traffic services within the area indicated under GEN 3.3.2 below.

### GEN 3.3.2 Area of responsibility

Air traffic services are provided for the entire territory of Namibia including its territorial waters as well as the airspace over the high seas within the Windhoek FIR.

In some cases, in accordance with the regional air navigation agreement, air traffic services are provided, under the delegated authority, in the airspace within another bordering FIR. Details of such services are provided in section ENR 2.

### GEN 3.3.3 Types of service

The following types of services are provided:

- Aerodrome Control tower (TWR)
- Approach Control (APP)
- Area Control (ACC)
- Flight Information Service (FIS)
- Alerting Service (ALRS)

With the exception of services provided at military air bases, the following types of services are provided at aerodromes:

- Aerodrome Control (TWR).
- Aerodrome Flight Information Service (AFIS); and
- Automatic Terminal Information Service (ATIS), at certain aerodromes.

With exception to Zambezi Zipfel, oceanic and all the areas below TMA's, the following has been established:

The flight information centre providing flight information service.

- HR of operation : 0500 to 1700
- Frequency : 129.6 MHz North and 123.8 MHz South
- Callsign : Windhoek formation (from 1500ft/FL145)

### GEN 3.3.4 Co-ordination between the operator and ATS

Co-ordination between the operator and air traffic services is effected in accordance with 2.17 of ICAO Annex 11).

**GEN 3.3.5 Minimum flight altitude**

The minimum flight altitudes on the ATS routes, as presented in section ENR 3, have been determined to ensure at least 300 M vertical clearance above the highest obstacle within 4 KM on each side of the centre line of the route.

However, where the angular divergence of the navigational air signal, in combination with the distance between the navigation aids, could result in an aircraft being more than 8 KM on either side of the centre line, the 18 KM protection limit is increased by the extent to which the divergence is more than 8 KM from the centre line.
