Application for Aviation Event (FSS-GEN-FORM094)

Notes:

- (i) Aviation Events require thoughtful consideration to ensure that safety standards are set and maintained. The NCAA when considering an application for an Aviation Event, organised in terms of Regulation 91. 07.29 shall take cognisance of the additional risk such events may present.
- (ii) It should be noted that events will not be approved unless the organisers can guarantee an acceptable level of safety will be maintained during the event and due consideration is given to the protection of:
 - a) Event Participants
 - b) Spectating Public
 - c) Non-participating public
 - d) Major Infrastructure
 - e) Environment
- (iii) Aviation Events require significant amounts of information to be published in the Integrated Aeronautical Information Packages and as such require adequate notification and processing time from the NCAA.
- (iv) Applications for Airshows/Air-displays, large public demonstrations or events where airspace reservation is required require application to be made at least 150 days' in advance
- (v) Application for events others than those defined in (iv) above require application to be made at least 90 days' in advance
- (vi) Organisers of an Aviation Event are required comply with the requirements for application as published by the NCAA in Aeronautical Information Circulars detailing the Application for Aviation Events and Contents of an Aviation Event Manual
